# FEDERAL AUSTRALIAN SCREEN PRODUCTION INCENTIVE SCHEME.

International feature films made in Australia include **Don't Be Afraid of the Dark, The Chronicles of Narnia: The Voyage of the Dawn Treader, X-Men Origins: Wolverine, Knowing, Nim's Island, The Ruins, Where the Wild Things Are, Fool's Gold, Superman Returns, Ghost Rider, Happy Feet, Charlotte's Web, Aquamarine, House of Wax, Star Wars Episodes II – III, The Matrix trilogy, The Proposition and Peter Pan.**

Television series and mini-series include **The Pacific, Nightmares and Dreamscapes: From the Stories of Stephen King, The Starter Wife, Monarch Cove, Salem's Lot, Mary Bryant, Farscape** and reality series include **The Real World, I'm a Celebrity Get Me Out of Here!** and **Real World/Road Rules Challenge.**

The Federal Australian Screen Production Incentive scheme comprises three mutually-exclusive strands which can be combined with Australian State and Territory incentives. Screen production incentives in Australia are not investor-based and they do not affect recoupment. Payments are prompt and, unlike many competing schemes, there is no cap.

## **THE AUSTRALIAN SCREEN PRODUCTION INCENTIVE SCHEME HAS THREE MUTUALLY-EXCLUSIVE STRANDS:**

The Location and PDV Offsets do not apply nationality or cultural tests however there are other eligibility requirements. The 40% Producer Offset can apply to co-productions and international joint ventures which satisfy the significant Australian content test administered by Screen Australia.

Applicants to the scheme must be an Australian company, or a non-resident company with a permanent establishment in Australia and an Australian Business Number (ABN). The applicant company must be responsible for making all the arrangements for the making of the production or post, digital and visual effects production project.

The Location and PDV Offsets are administered by the Department of the Environment, Water, Heritage and the Arts (DEWHA), while the Producer Offset is administered by Screen Australia.

The Offsets are calculated as a percentage of Qualifying Australian Production Expenditure (QAPE).

# 15% REBATE ON QUALIFYING AUSTRALIAN PRODUCTION EXPENDITURE.

## LOCATION OFFSET

A 15% rebate on Qualifying Australian Production Expenditure (QAPE).

### ELIGIBILITY

Applicant companies are eligible if they are an Australian resident company or non-Australian resident company with permanent establishment in Australia and an Australian Business Number (ABN).

The production must have a total Qualifying Australian Production Expenditure (QAPE) of at least A\$15 million. QAPE includes most production costs such as cast and crew, but excludes financing; foreign development costs; foreign-held copyright acquisition; most general business overheads that are not incurred in relation to making the film; distribution; most publicity and promotion expenditure; deferrals; profit participation; residuals (except where paid out before the film is completed) and advances; and depreciating asset acquisition.

For productions with QAPE of between A\$15 million and A\$50 million, QAPE must represent at least 70% of the production's total (i.e. worldwide) production expenditure. Television series must spend an average of A\$1 million per hour of finished production.

The Location Offset cannot be combined with either the PDV Offset or the Producer Offset.

### APPLYING FOR A PROVISIONAL CERTIFICATE (OPTIONAL)

A company may apply to DEWHA for a provisional certificate during production. Although this does not provide a guarantee of final certification, it can assist in identifying those costs which can be counted as QAPE.

### APPLYING FOR FINAL CERTIFICATION

Following the completion of the production, the company applies to DEWHA for final certification. DEWHA will then assess the amount of QAPE incurred by the company. A production is regarded as complete for companies applying for the Location Offset in the following circumstances:

1. For productions with QAPE of between A\$15 million and A\$50 million, final certification may be applied for following completion of total (worldwide) production expenditure.
2. For productions with more than A\$50 million in QAPE, final certification may be applied for following completion of all production expenditure in Australia only (not the total production expenditure).

### CLAIMING THE OFFSET

The Offset is claimed by providing the final certificate with the company's tax return to the Australian Taxation Office.

The Offset amount is first applied against any of the production's tax liabilities, with the balance then promptly paid to the applicant company by the Australian Taxation Office.

# A 15% REBATE ON QUALIFYING PDV EXPENDITURE.

## POST, DIGITAL AND VISUAL EFFECTS PRODUCTION (PDV) OFFSET

A 15% rebate on qualifying PDV Expenditure (QAPE incurred in relation to PDV work) of A\$5 million. The production does not need to be filmed in Australia.

Qualifying expenditure includes (but is not limited to): visual effects, audio and visual editing and mixing, orchestration, green-screen photography and many other tasks. It can also include salaries, per diems and travel for PDV related staff and crew, as well as rental of relevant facilities and equipment.

The PDV Offset cannot be combined with either the Location or Producer Offset.

### ELIGIBILITY

Applicant companies are eligible if they are an Australian resident company or non-Australian resident company with permanent establishment in Australia and an Australian Business Number (ABN).

The production must have a total Qualifying Australian Production Expenditure (PDV related QAPE) of at least A\$5 million on a feature film, telemovie or television mini-series or series.

### APPLYING FOR A PROVISIONAL CERTIFICATE (OPTIONAL)

A company may apply for a provisional certificate during production to DEWHA. Although this does not provide a guarantee of final certification, it can assist in identifying those costs which can be counted as QAPE.

### APPLYING FOR FINAL CERTIFICATION

Following the completion of the production, the company applies to DEWHA for final certification. DEWHA will assess the amount of QAPE incurred by the company. Applications can be made when Qualifying Australian PDV Expenditure has finished.

### CLAIMING THE OFFSET

The Offset is claimed by providing the final certificate with the company's tax return to the Australian Taxation Office.

The Offset amount is first applied against any of the production's tax liabilities, with the balance then promptly paid to the applicant company by the Australian Taxation Office.

# AVAILABLE TO FEATURE FILMS AT 40% OF QUALIFYING EXPENDITURE.

## PRODUCER OFFSET

The Producer Offset is a tax-based incentive that provides a rebate on Qualifying Australian Production Expenditure (QAPE). It is available to feature films at 40% of qualifying expenditure and at 20% of qualifying expenditure for all other eligible formats as set out in the legislation and guidelines. A co-production certified by Screen Australia is also eligible to apply for the Producer Offset.

### ELIGIBILITY

Applicant companies are eligible if they are an Australian resident company or non-Australian resident company with permanent establishment in Australia and an Australian Business Number (ABN).

The two key criteria for accessing the Producer Offset are the ability of the applicant to demonstrate that the production has Significant Australian Content (SAC); and that the production meets the thresholds for expenditure relevant to the type of production.

The Producer Offset is available to production companies of film and television projects with Significant Australian Content (determined by Screen Australia), and co-productions certified by Screen Australia.

In defining whether a film has SAC, Screen Australia has regard to the following:

- // The subject matter of the film
- // The place where the film was made
- // The nationalities and places of residence of key creative personnel and other persons who took part in making the film
- // The details of the production expenditure incurred in respect of the film
- // Any other matters that Screen Australia considers to be relevant

The Producer Offset cannot be combined with either the Location or PDV Offset. Any company intending to apply for the Producer Offset should contact Screen Australia as early as possible to determine whether the project will be eligible.

# AVAILABLE TO FEATURE FILMS AT 40% OF QUALIFYING EXPENDITURE.

In addition to having Significant Australian Content (SAC), projects must meet minimum levels of Qualifying Australian Production Expenditure (QAPE) in order to be eligible, as set out below:

FORMAT	MINIMUM LEVELS OF QAPE	OFFSET (ON QAPE)
Feature films	A\$1 million total QAPE	<b>40%</b>
Single episode program other than a documentary	A\$1 million total QAPE, and QAPE of A\$800,000 per hour	<b>20%</b>
Single episode program, documentary	QAPE of A\$250,000 per hour, no minimum total QAPE	<b>20%</b>
Series (or season), documentary and animated film	QAPE of A\$250,00 per hour, no minimum total QAPE	<b>20%</b>
Television Series – One commercial half-hour minimum per episode for live action series, and One commercial quarter-hour minimum per episode for animated series; minimum of two and maximum of 65 episodes total.	A\$1 million total QAPE and QAPE of A\$500,000 per hour	<b>20%</b>
Short-form Animation (One commercial quarter-hour minimum)	A\$250,000, total QAPE and QAPE of A\$1 million per hour	<b>20%</b>

## APPLYING FOR A PROVISIONAL CERTIFICATE (OPTIONAL)

A company may apply for a provisional certificate before or during production. This may be a requirement for co-investment by Federal and State screen agencies, although it is not a prerequisite for a Final Certificate. It does not provide a guarantee of final certification; however, it can provide an indication of the extent to which the production qualifies under the Significant Australian Content (SAC) test, and assist in identifying those costs which can be counted towards QAPE.

## APPLYING FOR FINAL CERTIFICATION

Following the completion of the production, the company applies to Screen Australia for final certification. Screen Australia will also determine final QAPE, which serves as the base for the calculations for the payment of the offset by the Australian Taxation Office.

Applications can be made when the production is completed, all expenditure has ceased and the project has evidence of distribution.

## CLAIMING THE OFFSET

The Final Certificate issued by Screen Australia must be submitted as part of the applicant company's tax return for the given income year in which the production was completed. The final offset will be paid against the company's Australian tax liabilities for the income year in which the production was completed, with the remainder refunded to the company.

# AUSTRALIA'S STATE SCREEN AGENCY INCENTIVES.

## NEW SOUTH WALES: SYDNEY

Where else can you find a spectacular range of stunning and unique locations, Australia's best studio complex, world-class crews and talent and leading post, digital and visual effects houses, all just a few minutes from the world's most famous beach? As the hub of the Australian screen industry, Sydney has it all, and has attracted some of the biggest films to shoot in Australia. Sydney and surrounding areas have doubled for downtown Metropolis and rural Smallville in **Superman Returns**, Normandy's D-Day beaches in **X-Men Origins: Wolverine**, Korea's DMZ and an Alaskan airbase in **Stealth**, and even Seville in **Mission: Impossible II**. New South Wales (NSW) continues to attract both international and interstate footloose productions to film in the State, and the attractive financial incentives reflect this.

### FILM AND TELEVISION INDUSTRY ATTRACTION FUND (FIAT)

A broad and flexible grant designed to attract international and interstate production and post-production to NSW. Offered as a cash rebate calculated on the total production spend in NSW, the incentive is assessed on a case-by-case basis using a range of criteria, including labour costs, the number of local cast and crew employed, regional locations used, new technology employed, whether post-production is included and the direct economic benefit to the state. The NSW Government is keen to maintain the State's enviable reputation as Australia's leader in post-production, digital and visual effects (PDV), and so "PDV only" projects are also highly sought after.

Eligible projects must have a minimum production spend of A\$5million in NSW, or minimum post-production costs of A\$3 million in NSW.

## QUEENSLAND: BRISBANE/GOLD COAST/CAIRNS

The Queensland Government through Screen Queensland may offer a State Payroll Tax Rebate and other incentives to productions meeting minimum Queensland Production Expenditure (QPE) criteria. Please note that the provision of cash incentives is subject to sufficient funding being available at the time of application.

Types of productions eligible to apply for the Rebate and for production incentives include feature films, telemovies and television series (including reality, drama, animation and mini-series).

### STATE PAYROLL TAX REBATE

Queensland offers a rebate of State Payroll Tax based on the eligible payroll for productions. Single projects must have a Queensland expenditure \$3.5m. Two (2) or more productions with individual Queensland expenditure of \$1m and combined Queensland expenditure of \$5m may be bundled within a four (4) year period, by one (1) production company or production services company. This rebate is paid directly by the Queensland Office of State Revenue from its funds. Screen Queensland facilitates these claims on behalf of eligible productions.

### PRODUCTION INCENTIVES

Queensland has two (2) dedicated cash-based production incentives, both of which are targeted at the hire of local Queensland labour. They are the **12.5% State Labour Incentive** and **Head of Department Incentive**.

### 12.5% STATE LABOUR INCENTIVE

This incentive is calculated as 12.5% of the basic salary/wage costs (other than rebateable payroll tax) of bona fide Queensland cast and crew employed on the production. The incentive will be subject to a remuneration package ceiling of \$2,500 per week per employee. An incentive will still be available for staff earning in excess of this amount, but the incentive will be calculated with reference to the ceiling rate.

The amount of incentive will be capped and linked to qualifying production expenditure.

There are two categories of eligibility for the 12.5% State Labour Incentive:

1. Drama productions (including animation productions)
2. Non-drama productions (including reality)

### HEAD OF DEPARTMENT INCENTIVE

Individual cash-based rebates are available to encourage the hire of Queensland Heads of Department. Each eligible Head of Department must:

- // Be directly employed by the production for a minimum ten (10) week period;
- // Hire a minimum of four (4) bona fide Queensland resident crew (as defined in the guidelines) in their department who are their direct subordinates.

To qualify for this incentive, a production must satisfy minimum Queensland Production Expenditure levels.

### PRODUCTION INVESTMENT ATTRACTION FUND

Designed to attract interstate or offshore feature films, television series, mini-series, telemovies, animation series, reality programs and documentaries to film and/or post-produce in Victoria. The grant is offered as a cash rebate, and is calculated on the total production spend in Victoria, with the offer increasing in value for undertaking post-production, VFX and Digital production, and maximising the employment of Victorian cast and crew.

- // Eligibility: A minimum of 70% of the total production budget or A\$3.5 million must be spent in Victoria.
- // In the case of the post production only grants, a minimum of three Victorian post production services must be used.

### REGIONAL VICTORIA FILM LOCATION ASSISTANCE FUND (RLAF)

Designed to encourage filmmakers to use locations outside metropolitan Melbourne, the grant assists projects by offsetting some of the additional costs incurred when filming in regional areas such as accommodation, living overheads and travel. The grant is offered as a cash rebate, and is calculated on the total production spend in regional Victoria.

- // Projects must utilise regional Victorian locations during principal photography for a minimum of five shooting days
- // RLAF Grants are capped at A\$100,000 per project.

The Northern Territory is the home of the World Heritage-listed Kakadu and the Uluru National Parks and is often described as Australia's last frontier.

While no formal incentive programs are in operation at present, significant projects are evaluated on a case-by-case basis. Contact the NT Film Office for details.
